- I. Call to order by Lynn Matsubara at 11:10 A.M. Also in attendance: Lynn Matsubara, Stacey Kosaka, Teri Erickson, Kim Schwarz, and Lynne Tomita.
- II. Corrected minutes from January 16, 2010 were approved.
- III. Treasurer's Report by Jane Taguchi – checkbook balance: \$3,697.39 as of July 17, 2010. Jane presented a copy of the Treasurer's report to all that attended and a revised Profit & Loss statement.
