



Minutes of June 23, 2007

The meeting of the Southern California Nikkei Bowling Association was called to order at 11:12 a.m. on June 23, 2007 by President Eric Yokoyama, at Premiere Lanes in Santa Fe Springs.

The minutes of the meeting of March 3, 2007 were read; the location of SNCNBA Roll-Off Tournament was corrected (Canoga Park Lanes instead of Corbin Bowl). The minutes were approved as corrected.

Treasurer's Report: (Liz Hamada)

- Joint Balance of the Mens & Womens Association: \$4,677.45
- Three (3) checks totaling \$150 have not yet been cashed; all 3 were issued to Angela Koga.
- The usage fee of \$25 from the Beverly Sansei Tournament is still due
 - Alice will check with the Committee on the outstanding payment

Membership Report: (Cori Murakami)

- Ytd Total 486 memberships (312 Mens and 174 Womens)
- Premiere Tournament (cancelled for 2007) usually sells approximately 30 cards
- Pasadena Tournament current lane assignment listing appears to have 9 bowlers who need to purchase their current membership cards

 - Note: there are two "Mike Lees", (1) is eligible, (1) not eligible
- Pasadena Nisei Mixed league is nearing non-qualifying as a Nikkei league; Cori has sent a letter notifying the league of their pending status

 - Results have been posted; Nationals has been notified
 - Pay-offs were made on the same day as the tournament
 - 20 teams participated

 - Open Team, no Seniors, with 780 maximum team average
 - work schedule assigned
- Pasadena Tournament (Alice Shiozawa)
 - Scheduled for 6/30 and 7/1, at Beverly
 - Still open spots for all events

- SCNBA Singles Tournament – Cerritos Lanes on Saturday 8/4/07
 - Sanctions to be sent Wednesday 6/27; comments due to Lynn by Monday
 - Possibly will be held annually at Cerritos
 - SCNBA will donate to the prize fund -- possibly \$200 to each division
 - Give-a-way bag/item and letter to be determined (Stacee Kosaka)

Unfinished Business:

- Women's checking account to be closed; funds will be deposited and merged with existing Men's checking account
- One (1) set of officers and board will be established
