Southern California NBA Overview

The purpose of the Southern California Nikkei Bowling Association is to increase the general interest in the game of bowling within the heritage of the Japanese culture and community allowing its members to foster and encourage the spirit of good fellowship, keen competition, sportsmanship, and fair dealings in all its bowling activities.

The SCNBA provides the following services for membership:

- a. Average verification (last two years)
- b. On-site tournament membership processing and tournament assistance
- c. Supplies average books for both NBA and non-NBA Nisei sanctioned tournaments
- d. Assists members with United States Bowling Congress (USBC) rules and regulations questions or problems
- e. Bonus Tournament awards for 300 games (NBA sanctioned tournaments only)
- f. Bonus Tournament awards for the highest scratch game bowled by a male, female, senior male and senior female (NBA sanctioned tournaments only)

NBA Membership Eligibility

All USBC certified Nikkei bowling leagues in Southern California are eligible for SCNBA membership if the league as a whole contains a minimum of 2/3 Japanese ancestry (including substitutes) and current SCNBA members. (See specific membership eligibility rules in the by-laws).

All SCNBA members must be in good standing with the USBC and must meet the eligibility criteria as outlined in the SCNBA By-Laws.

An individual may be expelled from membership for the following items:

- Failure to abide by the rules, regulations and decisions of the SCNBA Board of Directors
- Failure to abide by the rules and regulations of the USBC

NOTE: The term NIKKEI BOWLING LEAGUE refers to a USBC certified league having not less than two-thirds (2/3's) of its bowlers, including substitutes, being of Japanese or Japanese family ancestry and non-Japanese belonging to the SCNBA. If a league falls below the two-thirds (2/3's) figure, the non-Japanese bowlers shall not be eligible for membership.

NOTE: Membership renewal for a non-Japanese NBA member can be re-established by currently bowling half (1/2) of the winter season games as a regular member to date.

Positions

Nominees must be current NBA card holders in good standing with the USBC and be currently bowling in an approved SCNBA Nikkei league. A working knowledge of USBC rules is helpful and can be available to attend meetings on the weekends and possibly on weeknights.

DIRECTORS: We also need directors representing their Nikkei leagues **(NO RESUME NECESSARY, JUST PLEASE COME TO THE NEXT SCHEDULED MEETING!)** Communication is the key and we need every league represented. Directors will attend all meetings, deliver any pertaining information back to their league, and will help promote the services and purpose of the SCNBA. **See duties attached on next page.**

Position Descriptions

President

The President shall preside at all meetings; appoint committees and be responsible for enforcing the organization's purposes and objectives; shall represent the association at all City Association Board of Directors meetings; shall arrange for an annual audit of the organization's finances and provide for at least two signatures (by adult advisors) on all account withdrawals; and shall perform such other duties as specified by the USBC rules and regulations.

Vice President

The vice president shall, in the absence of the president, perform the duties of that office and shall discharge such other duties as may be assigned.

Treasurer

The Treasurer shall receive and deposit in appropriate bank accounts all monies of the Association; shall disperse such funds as directed by resolution of the Board by checks signed by any two of the following: President, Recording Secretary, or Treasurer; shall keep a true record of all receipts and expenses of any transaction of the Association; shall prepare at all times, and at the close of the fiscal year to exhibit and deliver to the Board, all records of monies collected and deposited in the treasury, and all other papers or correspondence that may have been handled through the office; and shall perform such other duties as may be required by the Board.

Secretary

The Secretary shall record the votes and keep the minutes of the meetings and proceedings of the Board and its members; shall also have charge of and shall conduct all correspondence of the association; shall serve notice of meetings of the Board and of its members; shall keep appropriate records showing the recognized league representatives, together with their addresses; shall keep for permanent record, an account of proceedings of all meetings; and shall perform such other duties as may be required by the Board.

Sergeant-at-Arms

The Sergeant-at-Arms shall see that the meetings are conducted in an orderly manner, and shall perform other duties as may be required by the Board.

Directors

To be the voice and representative of the SCNBA to the Nikkei league. To deliver any information that pertains to business directly affecting Nikkei leagues. It is also the Director's responsibility to help promote the services and purpose of the SCNBA.
