ELIGIBILITY: (PLEASE INDICATE ABOVE)

A. NIKKEI, ASIAN OR POLYNESIAN ANCESTRY.

B. NON-NIKKEI, NON-ASIAN, NON-POLYNESIAN MARRIED TO ABOVE.

C. NON-NIKKEI WHO IS CURRENTLY BOWLING OR HAS BOWLED IN A NIKKEI, ASIAN, POLYNESIAN LEAGUE.

1. Bowling tournament is open to:
 - (A) All Nikkei (Japanese Ancestry), Asian and Polynesian bowlers.
 - (B) Non-Nikkei, Non-Asian, Non-Polynesian married to above.
 - (C) Non-Nikkei who is currently bowling or had bowled in a Nikkei, Asian, Polynesian league.
2. This tournament shall be governed by the rules and regulations of the United States Bowling Congress (USBC). USBC members and non-members may participate in a USBC Moral Support certified tournament with award recognition automatically extended to USBC members. Eligible non-USBC members can qualify for USBC awards by purchasing an associate membership card and paying National dues (\$10) plus actual dues charged by the local and state association the bowler is joining. When local and state dues are not know, adult associate due will be \$21.00.
3. Mixed team shall consist of 2 women and 2 men.
 Mixed doubles shall consist of 1 woman and 1 man. (RULE 315: MAY BOWL TWO SQUADS, CASH ONLY ONCE WITH SAME PARTNER.)
 5-game singles event opened to men and women.
 Senior singles event opened to men and women. **(Note: Senior events minimum age: Women 55 years , Men 60 Years)**
 Senior doubles opened to men & women. **Any combination of a man and woman or two women - no maximum entering average.**
Two men - the maximum entering average is 360.
 Bowlers must bowl in order listed. Substitutes must bowl in position of original entrant.
4. Prize money will be returned 100%. Prize ratio will be one out of eight entries.
5. Handicap: 90% of 225
6. Tournament entering average shall be determined from the highest of A or B:
 - A. Highest 2008-2009 (April 15, 2009) league sanctioned average.
 - B. Highest 2009-2010 (April 15, 2010) league sanctioned average.
 (If none of the above use the following:)
 - C. Highest summer league sanctioned average of 21 games or more as of September 4, 2010. (Must provide ending league sheet.)
 - D. If none of the above, bowler must bowl scratch (no handicap).
 - E. Minimum entering average: Women: 125 average Men: 150 average
7. USBC rule 319a-3 is in effect. It shall be the bowler's responsibility to verify the accuracy of his or her average . Failure to use the proper average shall disqualify the score if the submitted average is lower than the actual average ir base prize winnings on submitted average if it is higher. Correction in averages may be submitted up to the completion of the first game.
8. A bowler whose average has been re-adjusted (Re-rated) by a bowling tournament or association in the previous 12 month period, must report the re-adjusted average (whether accepted or not) when submitting entry. The re-adjusted average or highest book average will be used. Failure to comply shall be cause to forfeit all entry fees and prize winnings.
9. The tournament committee reserves the right to re-adjust bowlers prior to the time he or she bowls.
10. A bowler who has qualified for a total amount of \$600.00 or more in any bowling tournament within the previous 12 month period must report (1) book average used, (2) actual score, (3) position placed, (4) amount won - to the tournament committee at the time of entry for possible re-adjustment. Failure to comply will be cause to forfeit tournament entry fee and prize winnings. (Bowler who submits report at time of bowling will be subject to automatically have their average re-adjusted accordingly.)
11. Late arrivals must bowl from frame in progress.
12. Entry with earliest post mark shall have time preference. Entry fee must accompany entry form(s).
 Entries without total fees will not be scheduled until fee is paid. No entry fee shall be returned.
 In case an entrant's choice of squad is filled and no second choice is given, the tournament committee reserves the right to assign entry to another squad.
13. Out-of-town bowlers (outside of the 50 miles radius) must submit the average verifications (showing the averages for the required two years), signed by city association secretary or league secretary and submitted by the entry deadline date.
14. Any bowler who is a member of a professional bowling association within the past 24 month period shall enter the tournament with a minimum of: **MEN 225 AVERAGE WOMEN-200 AVERAGE.**
 Failure to comply shall be cause to forfeit all entry fees and prize winnings.
15. Additional squads may be added during the course of the tournament as deemed necessary by tournament management, but no squad shall be added after the last advertised squad time.
16. USBC Rule 319e will be in effect for all participants.
17. USBC Rule 319a-2 will be waived.
18. Protests - Rule 329 Protests involving eligibility or playing rules must be made to tournament management in writing within the time limits in Rule 329. The decision of tournament management will be final unless a written appeal is filed with USBC Headquarters within the time limits in Rule 329.
19. Deadline to submit entry is **September 11, 2010**
20. Failure to comply with all rules shall be cause to forfeit all entry fees and prize winnings.
21. All scoring disputes must be brought to the attention of a committee member before the end of the game in question.
 Committee has final judgment on disputes.
